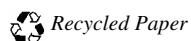

On November 7, 2006 and June 14, 2007, the Regional Board received Closure Monitoring Reports for the El Moro Mobile Home (Trailer) Park, including a request for the Regional Board to rescind Order No. R9-2003-0228, *Waste Discharge Requirements for California Department of Parks and Recreation, Crystal Cove State Park, El Morro Trailer Park, Orange County*, and Order No. R9-2003-0285, *Against California Department of Parks and Recreation, Crystal Cove State Park, El Morro Trailer Park, Orange County, To Establish a Time Schedule to Comply with Waste Discharge Requirements Order No. R9-2003-0228*.
