**SUBJECT: REVIEW OF MONITORING REPORT FOR ORDER NO. 93-012  
PUERTA LA CRUZ CONSERVATION CAMP**

The California Regional Water Quality Control Board, San Diego Region (San Diego Water Board) has reviewed the January-December 2010 annual monitoring report submitted by the California Department of Forestry and Fire Protection (Calfire) in accordance with Monitoring and Reporting Program (M&RP) No. 93-012.

The following violations of M&RP No. 93-012 were identified in the report submitted:

1. Groundwater analyses results for Total Dissolved Solids (TDS) and chloride were not included in the submitted report. Section C (Ground Waters) requires Calfire to submit groundwater analysis results for the above mentioned constituents annually.
2. Supply water analyses results for TDS were not included in the submitted report. Section D (Supply Waters) requires Calfire to submit supply water analyses results for TDS annually.
3. Information regarding sludge disposal was not included in the 2009 annual report. Section E (Sewage Solids) requires Calfire to submit a summary of the type, quantity, location and manner of solids removed during sewage treatment annually.

Please be aware these violations subject Calfire to possible further enforcement action by the San Diego Water Board, including administrative enforcement orders requiring Calfire to cease and desist from violations, or to clean up waste and abate existing or threatened conditions of pollution or nuisance; administrative assessment of civil liability


in amounts of up to \$5,000 per day per violation;<sup>1</sup> referral to the State Attorney General for injunctive relief; and referral to the District Attorney for criminal prosecution.

The next monitoring report required to be submitted is the January-December 2011 annual report, which is due by February 28, 2012.
