The California Regional Water Quality Control Board, San Diego Region (San Diego Water Board), is releasing Tentative Order No. R9-2024-0001, Conditional Waivers of Waste Discharge Requirements for Low Threat Discharges in the San Diego Region (Tentative Order), for public review and comment. The San Diego Water Board will consider adoption the Tentative Order at its regularly scheduled meeting on **March 13**, **2024**. The Tentative Order, if adopted, will replace Order No. R9-2019-0005, Conditional Waivers of Waste Discharge Requirements for Low Threat Discharges in the San Diego Region.

and will not be incorporated into the administrative record if doing so would prejudice any party.
