ADMINISTRATIVE ASSESSMENT OF CIVIL LIABILITY
AGAINST
NEXT GENERATION GELCOAT, INC.

FOR
VIOLATION OF
STATE BOARD ORDER NO. 97-03-DWQ

The California Regional Water Quality Control Board, San Diego Region (Regional Board), having held a public hearing on August 16, 2006, to hear evidence and comments on the allegations contained in Complaint No. R9-2006-0081, dated June 6, 2006, and deliberating on the evidence presented at the public hearing and in the record, after determining the allegations contained in the Complaint to be true, and on the recommendation for administrative assessment of Civil Liability in the amount of \$2,500 finds as follows:

1. Next Generation Gelcoat, Inc. filed a Notice of Intent on June 21, 2004 for coverage under State Board Order No. 97-03-DWQ, *National Pollutant Discharge Elimination System General Permit No. CAS000001, Waste Discharge Requirements for Discharges of Storm Water Associated with Industrial Activities Excluding Construction Activities (General Permit)*.
2. Order No. 97-03-DWQ requires the submittal of an annual storm water monitoring report by July 1 of each year. Next Generation Gelcoat, Inc. failed to submit the Fiscal Year 2004-05 annual report.
3. Consideration of the factors prescribed in California Water Code section 13385(e) based upon information available to the Regional Board supports the assessment of civil liability in the amount of three thousand five hundred dollars (\$3,500).
4. The Regional Board incurred costs of \$1,500 to prosecute the enforcement action, including: investigation, preparation of enforcement documents, communications with the Discharger, and preparation of materials for public review and hearing.
5. Issuance of this Order is exempt from the provisions of the California Environmental Quality Act (Public Resources Code section 21000 et seq.)
