RE: ACL COMPLAINT NO. R9-2010-0085 – EASTERN MUNICIPAL WATER DISTRICT, SET FOR HEARING NOVEMBER 10, 2010; PROSECUTION TEAM'S NOTICE OF POTENTIAL BIAS OF BOARD MEMBER GREEN

This is to call the Advisory Team's attention to a letter authored by newly-appointed Board Member William L. Green, which is addressed to Mr. Anthony J. Pack, General Manager of the named Discharger in the above-referenced proceeding. (A true and correct copy of the letter, with handwritten notes apparently from Mr. Green, is enclosed herewith.) The Prosecution Team believes the letter subjects Mr. Green to potential disqualification in this proceeding for bias, prejudice, and/or personal interest. (*See* Gov. Code, §§ 11425.10(a)(5), 11425.40(c).)

As you are no doubt well-aware, the Administrative Adjudication Code of Ethics, which incorporates certain provisions of the Code of Judicial Ethics, applies to this proceeding. (Gov. Code, § 11475.20.) Canons 2 and 3 of the Code of Judicial Ethics, require Mr. Green to "avoid all impropriety or the appearance of impropriety[,]" to "be faithful to the law regardless of partisan interests[,]" and to "perform judicial duties without bias or prejudice." (Code of Judicial Ethics, Canon 2 Advisory Committee Commentary; Canon 3(B)(2); Canon 3(b)(5), respectively.) The enclosed letter to the Discharger's General Manager requests his endorsement for the position Mr. Green now holds on the Regional Board. It is unclear whether the request for endorsement is being made to Mr. Pack as a friend, or in Mr. Pack's capacity as the Discharger's General Manager, particularly in light of the handwritten notation "Thank you Tony" below the signature block. In either event, the letter certainly raises, at a minimum, the appearance of impropriety, and a reasonable inference that Mr. Green may have a personal interest in the outcome of this proceeding, or be biased in favor of his friend or the entity who endorsed him for this position on the Regional Board.

Accordingly, the Prosecution Team respectfully requests that Mr. Green either recuse himself from participating in the adjudication of this matter, or state on the record at the

beginning of the hearing that he is capable of adjudicating this matter without bias, in a fair and impartial manner, despite his relationship with the Discharger.
