**SUBJECT: TENTATIVE ORDER NO. R9-2010-0057, AN ORDER MODIFYING
ORDER NO. R9-2009-0081, NPDES PERMIT NO. CA0109185, WASTE
DISCHARGE REQUIREMENTS FOR THE UNITED STATES
DEPARTMENT OF THE NAVY, NAVAL BASE CORONADO, SAN
DIEGO COUNTY**

The California Regional Water Quality Control Board, San Diego Region (San Diego Water Board) intends to consider adoption of enclosed subject tentative Order at a San Diego Water Board meeting on September 8, 2010. The tentative Order would, if adopted, modify National Pollutant Discharge Elimination System (NPDES) waste discharge requirements (WDR) for the discharge of waste from Naval Base Coronado. This modification would change requirements for "Steam Condensate," "Mammal Enclosure," "Pier Boom," and "TCDD-Equivalents."

The tentative Order will be presented to the San Diego Water Board on Wednesday, September 8, 2010. The meeting will begin promptly at 9:00 AM and will be held at the following location:

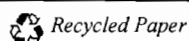

Please be aware that written material submitted to the San Diego Water Board office after the September 1, 2010 submittal deadline date will not be provided to the San Diego Water Board members. Also, it is not likely that written material will be accepted by the San Diego Water Board on the day of the meeting.
