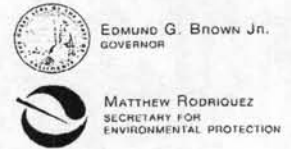

Subject: Notice of Availability of Tentative Order No. R9-2012-0054 and Opportunity for Public Comment


Ms. Kaludjerski Schipper:

This serves to inform you that a revised version of Tentative Order No. R9-2012-0054 (tentative Order), *Waste Discharge Requirements for the San Diego County Sanitation District-Harmony Grove Service Area, Harmony Grove Water Reclamation Plant, San Diego County* is available for public comment. Revisions to the August 14, 2012 version of the tentative Order are shown in underline/strikeout format in the enclosed copy of the tentative Order. The tentative Order, if adopted, would prescribe requirements for the treatment and discharge of up to 180,000 gallons per day (gpd) of disinfected tertiary treated wastewater from the proposed Harmony Grove Water Reclamation Plant (plant).

Please review and comment on the tentative Order at your earliest convenience. The revised tentative Order will be scheduled for hearing at a future meeting of the California Regional Water Quality Control Board, San Diego Region (San Diego Water Board). Notice of the hearing will be provided in the notice and agenda for the meeting at least 10 days before the meeting.
