## Subject: Consideration of Adoption of Revised Tentative Addendum No. 1 to Order No. 2000-10, An Addendum Modifying Master Recycled Water Permit for the Production and Purveyance of Recycled Water for San Elijo Joint Powers Authority, San Dieguito Water District, Santa Fe Irrigation District, and City of Del Mar, San Diego County

Mr. Thornton:

Enclosed is a revised copy of Tentative Addendum No. 1 to Order No. 2000-10 (tentative Addendum), which, if adopted, would modify Order No. 2000-10, *Master Recycled Water Permit for the Production and Purveyance of Recycled Water for San Elijo Joint Powers Authority, San Dieguito Water District, Santa Fe Irrigation District, and City of Del Mar, San Elijo Water Reclamation Facility, San Diego County.* The proposed revised tentative Addendum would modify Order No. 2000-10, and ensure compliance with the State Water Board Recycled Water Policy (2009),<sup>1</sup> in the following ways:

- 1. Require the SEJPA to provide a proposed schedule for preparation of a salt and nutrient management plan for the San Elijo groundwater basin (Hydrologic Subarea 4.61).
- 2. Requires the SEJPA to develop an Operations and Management plan to ensure application of recycled water and fertilizers will not exceed nutrient demands of landscape vegetation (i.e., ensure application of recycled water at agronomic rates).
- 3. Require the SEJPA to implement semiannual monitoring (and annual reporting) of its recycled water discharge for priority pollutants.
