This letter serves to inform you that the California Regional Water Quality Control Board, San Diego Region (San Diego Water Board) will consider adoption of Tentative Order No. R9-2016-0117, *Water Reclamation Requirements for the City of Poway, San Diego County* (Tentative Order) at its scheduled meeting on Wednesday, August 10, 2016. The Tentative Order, if adopted, would prescribe requirements for the purveyance and distribution of recycled water by the City of Poway within the Poway Hydrologic Area. 

The San Diego Water Board will also consider adoption of the Tentative Order at its regularly scheduled meeting on **August 10, 2016**.

The Tentative Order, if adopted, would prescribe requirements for the purveyance and distribution of recycled water by the City of Poway within the Poway Hydrologic Area.

The early submission of written comments on the Tentative Order is encouraged. Written comments received by **5:00 p.m. on June 20, 2016**, will be provided to the San Diego Water Board members for their review in advance of the public hearing to consider adoption of the Tentative Order. The San Diego Water Board will prepare written responses to significant comments that are timely received. Consistent with State Water Resources Control Board regulations that apply to this proceeding, written comments received after **5:00 p.m. on June 20, 2016**, will not be accepted, and will not be incorporated into the administrative record if doing so would prejudice any party.
