# **Public Comment**

Fishing Resource but not a citizen expert and not meant to be a substitute for public comment period



### **Boat Anglers**

- Access to boat anglers was more difficult and resulted in a lower number of responses relative to pier and shoreline anglers, however, given the survey design and number of responses from boat based anglers, we believe the sampled population of boat anglers, while potentially underreporting overall fishing activity relative to other modes, is representative of consumption behavior of the boat based anglers. Nonetheless, these constrains should be taken into consideration when reviewing the results. (Page 8 of the Report)
  - Undercount boat anglers
  - This report shows boat anglers consume at a lower rate than shoreline and pier anglers
  - Therefore, undercounting boat anglers overstates fish consumption

# **Fishing Populations Not Included**

- Kayaks included as boaters but not differentiated in the data
- Float tubers not included
- Float tubers and Kayak anglers also tend to be catch and release
- Report would be enhanced by additional of an uncertainty section



# Do you consume fish?

Of all those completing the survey, just over half (51%) do not eat fish, most of which consisted of San Diego county residents (48% of those surveyed), with 3% coming from outside the county. Similarly, of those surveyed, the vast majority of anglers who eat fish, 46% lived within San Diego County, with 3% coming from elsewhere. (Figure 12). (Page 26 of the Report)

## **Catch and Release**

In particular, we sought to differentiate how many anglers are fishing for recreation (anglers practicing catch and release) versus those who keep and consume some portion of their catch. (Executive Summary)

- Other than ES and Page 1 no discussion of catch and release
- As stated by the report fish consumption rates are fairly low
  - More likely far lower than reported
