The California Regional Water Quality Control Board, San Diego Region (San Diego Water Board) is releasing Tentative Order No. R9-2019-0005, *Conditional Waivers of Waste Discharge Requirements for Low Threat Discharges in the San Diego Region* (Tentative Order) for public review and comment. The San Diego Water Board will consider adoption of the Tentative Order at its regularly scheduled meeting on **April 10**, **2019**. The Tentative Order proposes to adopt conditional waivers of waste discharge requirements for low threat discharges in the San Diego Region. This Tentative Order renews and, in some instances, revises the prior Order, which is set to expire on June 26, 2019.

The conditional waivers issued through the adoption of the Tentative Order will require the implementation of effective management measures and structural and non-structural best management practices to address potential impacts associated with storm water run on and runoff, wastes, and wastewaters discharged from facilities or operations located within the San Diego Region.
