NOTICE OF PUBLIC HEARING AND WRITTEN COMMENT PERIOD

The California Regional Water Quality Control Board, San Diego Region (San Diego Water Board) is releasing Tentative Order No. R9-2019-0052, *An Order Rescinding Order No. R9-2007-0148* (Tentative Order) for public review and comment. The San Diego Water Board will consider adoption of the Tentative Order at its regularly scheduled meeting on **May 8, 2019**. The Tentative Order, if adopted, will rescind Order No. R9-2007-0148, *Waste Discharge Requirements for California Department of Transportation, Tecate Truck Inspection Station.*

The onsite wastewater treatment systems (OTWS) at the Tecate Truck Inspection Station will be transferred to the County of San Diego and regulated under its Local Agency Management Program (LAMP). The Lamp is designed to protect groundwater and surface water quality through the proper design, placement, installation, and assessment of individual OWTS. Consistent with State Water Resources Control Board regulations that apply to this proceeding, written comments received after **5:00 p.m. on Friday, March 29, 2019**, will not be accepted, and will not be incorporated into the administrative record if doing so would prejudice any party.
