The California Regional Water Quality Control Board, San Diego Region (San Diego Water Board) is releasing Tentative Order No. R9-2020-0133, *An Order Rescinding Order Nos. 93-69 and 95-84* (Tentative Order), for public review and comment. The San Diego Water Board will consider adoption of the Tentative Order at its regularly scheduled meeting on **August 12, 2020**. The Tentative Order, if adopted, will rescind Order No. 93-69, *Oak Crest Estates, Inc. and Rainbow Municipal Water District, Oak Crest Treatment Plant, San Diego County* (Order No. 93-69); and Order No. 95-84, *Waste Discharge Requirements for Mr. Charles Knapp, Tucalota Springs R.V. Park, Riverside County* (Order No. 95-84).

All written comments regarding the Tentative Order must be received no later than **5:00 p.m. on Tuesday, June 30, 2020,** to be considered by the San Diego Water Board. The early submission of written comments on the Tentative Order is encouraged. Written comments received by **5:00 p.m. on Tuesday, June 30, 2020,** will be provided to the San Diego Water Board members for their review in advance of the public hearing to consider adoption of the Tentative Order. The San Diego Water Board will prepare written responses to significant comments that are timely received. Consistent with State Water Resources Control Board regulations that apply to this proceeding, written comments received after **5:00 p.m. on Tuesday, June 30, 2020**, will not be accepted and will not be incorporated into the administrative record if doing so would prejudice any party.
