NOTICE OF PUBLIC HEARING AND WRITTEN COMMENT PERIOD

The California Regional Water Quality Control Board, San Diego Region (San Diego Water Board) is releasing Tentative Order No. R9-2020-0108, *Master Recycling Permit for Sudberry Development, Inc. and PERCWater, Civita Water Reclamation Facility, San Diego County* (Tentative Order), for public review and comment. The San Diego Water Board will consider adoption of the Tentative Order at its regularly scheduled meeting on **August 12, 2020.** The Tentative Order, if adopted, will establish requirements for the treatment and discharge of tertiary treated recycled water for the Civita Water Reclamation Facility.

Written comments received by **5:00 p.m. on Friday, June 12, 2020**, will be provided to the San Diego Water Board members for their review in advance of the public hearing to consider adoption of the Tentative Order. The San Diego Water Board will prepare written responses to significant comments that are timely received. Consistent with

State Water Resources Control Board regulations that apply to this proceeding, written comments received after **5:00 p.m. on Friday, June 12, 2020**, will not be accepted and will not be incorporated into the administrative record if doing so would prejudice any party.
