The California Regional Water Quality Control Board, San Diego Region (San Diego Water Board) is releasing Tentative Order No. R9-2020-0088, An Order Rescinding Order No. 86-32, An Order Prohibiting the Discharge of Wastes Beyond the Limits of Lands Owned or Controlled by Color Spot Foliage Inc., Near Fallbrook, San Diego County (Tentative Order), for public review and comment. Consistent with State Water Resources Control Board regulations that apply to this proceeding, written comments received after **5:00 p.m. on Tuesday June 16, 2020**, will not be accepted and will not be incorporated into the administrative record if doing so would prejudice any party.
