The California Regional Water Quality Control Board, San Diego Region (San Diego Water Board), is releasing Tentative Order No. R9-2020-0189, *An Order Rescinding Order No. R9-2006-0063, Waste Discharge Requirements for the California Department of Transportation, Descanso Maintenance Station, San Diego County* (Tentative Order), for public review and comment. The San Diego Water Board will consider adoption of the Tentative Order at its regularly scheduled meeting on **November 18, 2020**. The Tentative Order, if adopted, will rescind Order No. R9-2006-0063, *Waste Discharge Requirements for the California Department of Transportation, Descanso Maintenance Station, San Diego County*.

All written comments regarding the Tentative Order must be received no later than **5:00 p.m. on Monday, October 19, 2020,** to be considered by the San Diego Water Board. Early submission of written comments on the Tentative Order is encouraged. Written comments received by **5:00 p.m. on Monday, October 19, 2020,** will be provided to San Diego Water Board members for their review in advance of the public hearing to consider adoption of the Tentative Order. The San Diego Water Board will prepare

written responses to significant comments that are timely received. Consistent with State Water Resources Control Board regulations that apply to this proceeding, written comments received after **5:00 p.m. on Monday, October 19, 2020**, will not be accepted and will not be incorporated into the administrative record if doing so would prejudice any party.
