The California Regional Water Quality Control Board, San Diego Region (San Diego Water Board), is releasing Tentative Order No. R9-2021-0150, An Order Rescinding Order No. 93-13, Waste Discharge Requirements for the Warner Springs Ranch Resort LLC, Warner Springs Ranch Resort Wastewater Treatment Plant, San Diego County (Tentative Order), for public review and comment. The San Diego Water Board will consider adoption of the Tentative Order at its regularly scheduled meeting on September 8, 2021. The Tentative Order, if adopted, will rescind Order No. 93-13, Waste Discharge Requirements for the Warner Springs Ranch Resort LLC, Warner Springs Ranch Resort Wastewater Treatment Plant, San Diego County and Addenda.

The San Diego Water Board will prepare

written responses to significant comments that are timely received. Consistent with State Water Resources Control Board regulations that apply to this proceeding, written comments received after **5:00 p.m. on Monday, July 26, 2021**, will not be accepted and will not be incorporated into the administrative record if doing so would prejudice any party.
