**NOTICE OF PUBLIC HEARING AND WRITTEN COMMENT PERIOD**

The California Regional Water Quality Control Board, San Diego Region (San Diego Water Board) is releasing Tentative Order No. R9-2022-0049, *An Order Rescinding Order No. R9-2009-0009, Waste Discharge Requirements for the California Department of Forestry and Fire Protection, Rainbow Conservation Camp, San Diego County* (Tentative Order), for public review and comment. The San Diego Water Board is also providing a reference copy of the draft Notice of Applicability (NOA) for State Water Resources Control Board Order WQ 2014-0153-DWQ, *General Waste Discharge Requirements for Small Domestic Wastewater Treatment Systems* (General Order), which is anticipated to be issued to the California Department of Forestry and Fire Protection. The NOA provides the public with supporting information to clarify how enrollment of the Rainbow Conservation Camp in the General Order will control the discharge of nutrients in accordance with the Resolution No. R9-2005-0036, *A Resolution Adopting an Amendment to the Water Quality Control Plan for the San Diego Region (9) to Incorporate Total Maximum Daily Loads for Total Nitrogen and Total Phosphorus in the Rainbow Creek Watershed, San Diego County*. The San Diego Water Board will consider adoption of the Tentative Order at its regularly scheduled meeting on **September 14, 2022**. The Tentative Order, if adopted, will rescind Order No. R9-2009-0009, *Waste Discharge Requirements for the California Department of Forestry and Fire Protection, Rainbow Conservation Camp, San Diego County*.

**Submission of Written Comments**

Notice is hereby given that the San Diego Water Board will accept written comments regarding the Tentative Order in accordance with this notice and pursuant to Water Code section 13167.5.

The written comment period provides an opportunity for interested persons to comment on the Tentative Order. All written comments regarding the Tentative Order must be received no later than **5:00 p.m. on Friday, July 15, 2022**, to be considered by the San Diego Water Board. Written comments sent by mail must be addressed to California

The early submission of written comments on the Tentative Order is encouraged. Written comments received by **5:00 p.m. on Friday, July 15, 2022**, will be provided to the San Diego Water Board members for their review in advance of the public hearing to consider adoption of the Tentative Order. The San Diego Water Board will prepare written responses to significant comments that are timely received. Consistent with State Water Resources Control Board regulations that apply to this proceeding, written comments received after **5:00 p.m. on Friday, July 15, 2022**, will not be accepted and will not be incorporated into the administrative record if doing so would prejudice any party.
