MINUTES OF MEETING June 11, 2003

The regular meeting of the California Regional Water Quality Control Board, San Diego Region, was called to order by Chairman Minan at 9:00 a.m. at the Regional Water Quality Control Board, 9174 Sky Park Court, San Diego, California.

Richard Dietmeier, Director of South Coast Water District, talked about the conference on sanitary sewer overflow prevention they hosted on May 20, 2003 and about their spill prevention plan.

Board Member Butcher arrived at 9:05 a.m.

Mr. Stephany asked Mr. Robertus to address some of the problems Mr. Dietmeier talked about in the next Executive Officer's Report.

<u>Item 3</u> – Minutes of Board Meeting of May 14, 2003

Mr. Stephany moved approval of the May 14, 2003 minutes. The motion was seconded by Ms. Butcher and approved by unanimous vote.

<u>Item 4</u> – Chairman's, Board Member's, State Board Liaison's and Executive Officer's Reports.

Chairman Minan presented staff members David Barker, Pete Michael and Gloria Fulton with awards recognizing their 25 years of State service.

Executive Officer Robertus briefly spoke about a conference being held on June 20^{th} hosted by the County of San Diego as part of their clean water program, a \$70,000 grant obtained by UCSD to help build a 401 Water Quality Certifications database, and a possible 10 % reduction in staff.

Chairman Minan, Mr. Robertus and Mr. Richards talked about the language being developed on the 401 water quality certification process that will be standard language in future agenda notices.

Ms. Ghio talked about a concern she had with industrial storm water inspections and the duplication of permitting and fees. Mr. Robertus responded to Ms. Ghio's comments.

Chairman Minan said he would be attending a Chairs' meeting at the State Board on June 30, 2003.

Al Huang, on behalf of the Environmental Health Coalition, also presented a Resolution of Appreciation to Ms. Black.

Mr. Stephany moved approval of Items 6 - 12. The motion was seconded by Mr. Wright and approved by unanimous vote.

Chairman Minan explained the procedures that would be followed in presenting the item.

Mr. Stephany disclosed that he was the President of the Anglers Club at the San Diego Yacht Club and said he owned a couple of boats that he hoped to house in a San Diego marina in the future but felt he could make an unbiased decision.

Ms. Butcher disclosed that her son was a boat hull cleaner in a marina but also felt she could make an unbiased decision.

Mr. Robertus introduced the item and senior staff member Pete Michael gave the presentation.

Mr. Purdon made closing remarks.

Board Members asked questions of Mr. Purdon, Ms. Driscoll and Mr. Desmond.

The meeting was recessed for lunch at 12:45 p.m. and reconvened at 1:30 p.m.

<u>Item 13</u> (con't.)

Mr. Michael made closing statements.

Board Members asked questions of Mr. Michael, Mr. Richards and Mr. Robertus.

Mr. Robertus made comments, gave recommendations then asked the Board for their guidance.

After Board Member discussion, Chairman Minan recommended that the hearing be closed and the item be continued to allow staff to work on the permit.

Mr. Wright said if the item was continued, the implementation should not be delayed.

Mr. Robertus noted that some parts of the permit were required to be in the permit.

Board Members said they wanted to be sure that regulations in existing permits weren't duplicated in the new permit.

Mr. Richards' recommendation was to close the public comment period and open a new public comment period at a later date.

Ms. Ghio asked that, at a future meeting, staff tell the Board what different types of marina operations there are and what they do.

After further discussion, Mr. Stephany made a motion to close the hearing and direct staff to meet with the stakeholders to develop a permit that was more acceptable to all parties then bring the proposed permit back to the Board for consideration by the November 12, 2003 meeting. Ms. Butcher seconded the motion and asked that the three points made by Mr. Robertus; that all issues be brought forward, the requirements be made clear and the fact that it may end up being a vague permit, be included in the permit rewriting process. The motion was approved by unanimous vote.

<u>Item 14</u> – PUBLIC HEARING: Administrative Assessment of Civil Liability against Shea Homes for violation of SWRCB Order No. 99-08-DWQ, Waste Discharge Requirements for discharges of storm water runoff associated with the Kelly Core construction site located at Cannon Road and Faraday Avenue, Carlsbad in San Diego County. If the discharger elects to waive their right to a hearing, the matter will be rescheduled to allow for a 30-day public review period

at which time the Regional Board will consider adoption assessment of civil liability. (Tentative Order No. R9-2003-0253) (*Vicente Rodriguez*)

Item 14 was postponed.

<u>Item 15</u> – Referral to Attorney General: A Resolution directing the Executive Officer to request the Attorney General of the State of California to petition the appropriate court to collect \$3,000 from Castillo & Sons for failure to pay Regional Board Order No. R9-2002-0284, Administrative Assessment of Civil Liability Against Castillo & Sons, A&E Auto Recycling for Failure to Pay Annual Fees. (Tentative Resolution No. R9-2003-0164) (*Vicente Rodriguez*)

Mr. Robertus introduced the item and senior staff member Mark Alpert gave background information to the Board.

Daniel Castillo said he didn't have the money to pay the liability that was due by June 10, 2003 but asked if he could make a \$500 a month payment starting in June with a final payment in November 2003.

Mr. Robertus recommended making the \$500 a month payments due the 28th of each month, with the first payment due June 28th and the final payment due November 28, 2003. If a payment was missed, the matter would be referred to the Attorney General's office.

After Board Member discussion, Ms. Ghio made a motion to amend Resolution No. R9-2003-0164 to include the recommendation made by Mr. Robertus then adopt it. The motion was seconded by Ms. Butcher and approved by unanimous vote.

<u>Item 16</u> – Referral to Attorney General: A Resolution directing the Executive Officer to request the Attorney General of the State of California to petition the appropriate court to collect \$422,200 from William P. Johnson and Vail Lake, LLC for failure to pay Regional Board Order No. R9-2002-0027, Administrative Assessment of Civil Liability Against William P. Johnson And Vail Lake, LLC for Violations of California Water Code §§ 13267, 13383, and 13376, and State Water Resources Control Board Order No. 99-08-DWQ. (Tentative Resolution No. R9-2003-0245) (*Frank Melbourn*)

Item 16 was postponed.

<u>Item 17</u> – Revision of NPDES Permit Monitoring and Reporting Program: City of San Diego E.W. Blom Point Loma Metropolitan Wastewater Treatment Plant Discharge to the Pacific Ocean through the Point Loma Ocean Outfall. If adopted, this addendum would modify the monitoring and reporting program to incorporate recommendations of the Southern California Coastal Water Research Project's Model Monitoring Program for Large Ocean Discharges in Southern California. (Tentative Addendum No. 1 to Order No. 2002-0025, NPDES Permit No. CA0107409) (*David Hanson*)

Mr. Robertus introduced the item and staff member David Hanson gave the presentation.

Board Members asked questions of Mr. Hanson.

Alan Langworthy, City of San Diego, asked the Board to adopt the addendum.

Ed Kimura, Sierra Club, said he also supported the addendum.

Mr. Wright made a motion to adopt Addendum No. 1 to Order No. 2002-0025. The motion was seconded by Mr. Stephany and approved by unanimous vote.

<u>Item 18</u> – A Resolution modifying the Regional Board's Waiver Policy to make corrections in response to the results of the State Office of Administrative Law (OAL) review. The Board will consider adoption of a resolution that will make minor modifications and authorize the Executive Officer to make additional minor modifications to correct deficiencies identified by the OAL. (Tentative Resolution No. R9-2003-0262) (*Christina Arias*)

Mr. Robertus introduced the item and recommended adoption of the resolution.

Mr. Anderson asked a question of Ms. Arias about the enrollment form.

Mr. Stephany made a motion to adopt Resolution No. R9-2003-0262. The motion was seconded by Mr. Anderson and approved by unanimous vote.

<u>Item 19</u> – Status Report: U.S. Coast Guard and U.S. Navy Report on Fuel/Oil Spills in San Diego Bay (*John Robertus*)

Rick Sorrel, U.S. Coast Guard and Don Montoro, U.S. Navy gave a joint presentation.

Mr. Robertus and Mr. David Barker gave a brief status report. Board Members asked questions.
