> MINUTES OF MEETING APRIL 11, 2007

At 9:00 a.m. Vice Chairwoman Ritschel called to order the meeting of the California Regional Water Quality Control Board, San Diego Region at the Mission Viejo Civic Center, City Hall Council Chambers, 200 Civic Center, Mission Viejo, California.

The motion was seconded by Ms. Pearson Schneider and approved by unanimous vote.

<u>Item 5</u> – Chairman's, Board Members', State Board liaison's and Executive Officer's Reports: These items are for Board discussion only. No public testimony will be allowed, and the Board will take no formal action.

Mr. Johnson reported that he was involved in a technical work group dealing with low level lead impacted soils and how it relates to or possibly impacts Brownfield redevelopment and waste discharge requirements within the San Diego region.

Mr. Robertus spoke to the Board about letters he received from the Wildcoast International Conservation Team and Assembly Member Lori Saldana that requested an update from the U.S. International Boundary and Water Commission and Bajagua LLC on the Bajagua Project at the next Regional Board meeting. After discussion with other Board Members and staff, Mr. Wright asked that an item be put on a future meeting agenda to hear an update.

Mr. Robertus reported on issues dealing with the Cleanup and Abatement Order issued to Town and Country Hotel for discharges of waste into the river during a construction project in their parking lot. He also reported that the four petitions filed against the San Diego Municipal Storm Water Permit were all dismissed by the State Board and said they have 30 days to file a lawsuit. Lastly, he announced that the paperless office project *(electronic filing)* would go into effect in approximately two weeks in the San Diego Regional Board office.
