MINUTES OF MEETING MAY 9, 2007

At 9:00 a.m. Chairwoman Ritschel called to order the meeting of the California Regional Water Quality Control Board, San Diego Region at the Regional Water Quality Control Board, 9174 Sky Park Court, San Diego, California.

Item 2 – Public Forum

There were no requests to speak during the public forum.

<u>Item 4</u> – Chairman's, Board Members', State Board liaison's and Executive Officer's Reports: These items are for Board discussion only. No public testimony will be allowed, and the Board will take no formal action.

Ms. Fran Spivy-Weber, State Board liaison, briefly spoke about the Strategic Planning meeting that was being held later in the meeting.

Board Member King arrived at 9:05 p.m.

Mr. Robertus reported that Mr. Wright was the Regional Board's representative on the Wetlands Recovery Project and was also the Border Liaison. He said that a Regional Board representative needed to be assigned to the San Diego River Conservancy (non-voting position).

Chairwoman Ritschel reported that Mr. King would fill the position on the Conservancy and Mr. Wright would remain in the Wetlands Recovery Project and Border Liaison positions. Chairwoman Ritschel said she would serve as the alternate on the Conservancy and Mr. Anderson volunteered as the alternate Border Liaison.

Mr. Wright said he felt it was important that Board Members be involved in outreach opportunities and serve on committees as time permitted.

Item 3 – Minutes of Board Meeting of April 25, 2007

Chairwoman Ritschel noted that there was an errata to the minutes for Item 8.

Mr. Wright moved approval of the April 25, 2007 minutes with errata. The motion was seconded by Ms. Pearson Schneider and approved by unanimous vote.

<u>Item 4a</u> – Recognition: Resolution of Appreciation for Jennifer Kraus (tentative Order No. R9-2007-0075) and Alan Barrett (tentative Order No. R9-2007-0080) (*John Robertus*)

Chairwoman Ritschel presented the Resolution of Appreciation to former Board Member, Jennifer Kraus. Board Members thanked Ms. Kraus for her service on the Board.

Chairwoman Ritschel read the Resolution of Appreciation for former Board Member, Alan Barrett. Mr. Barrett could not present at the meeting.

Consent Calendar: Items 5 through 7 are considered non-controversial issues. (NOTE: If there is public interest, concern or discussion regarding any consent calendar item or a request for a public hearing, then the item(s) will be removed from the consent calendar and considered after all other agenda items have been completed.)

<u>Item 5</u> – Update of Waste Discharge Requirements and Master Reclamation Permit: Otay Water District – Ralph W. Chapman Water Reclamation Facility, San Diego County (tentative Order No. R9-2007-0038) (*Melissa Valdovinos*)

<u>Item 6</u> – Amendment of Waste Discharge Requirements: United States Marine Corps, Las Pulgas Landfill, Marine Corps Base, Camp Pendleton: Tentative Addendum No. 1 to Order No. 2000-54 (*Amy Grove*)

Item 7 – Settlement of Administrative Assessment of Civil Liability: South Orange County Wastewater Authority (SOCWA), San Juan Creek Ocean Outfall: The Regional Board will consider adoption of an order accepting settlement of a \$36,000 Mandatory Minimum Penalty against the SOCWA for violations of effluent limitations established by Order No. R9-2000-0013, Waste Discharge Requirements for the South Orange County Wastewater Authority, Orange County, Discharge to the Pacific Ocean through the South Orange County Wastewater Authority San Juan Creek Ocean Outfall. If the Regional Board rejects the settlement, the matter will be rescheduled to a future public hearing at which time the Regional Board will consider assessment of civil liability. (Tentative Order No. R9-2007-0070) (Rebecca Stewart)

Ms. Pearson Schneider disclosed that she was an alternate member of SOCWA but felt her participation in voting on Item 7 would not pose a conflict of interest.

Mr. Wright made a motion to approve Consent Items 5 through 7. The motion was seconded by Mr. King and approved by unanimous vote.

<u>Item 8</u>. – PUBLIC HEARING: Appeal of Water Quality Investigation Order No. R9-2006-0044, City of San Marcos Bradley Park/Old Linda Vista Landfill, San Diego County. The Regional Board will hear public testimony and comments regarding the City of San Marcos' appeal of Order R9-2006-0044. The Regional Board will be asked to affirm the Order as amended by tentative Addendum No. 3. (Tentative Addendum 3 to Order No. R9-2006-0044) (*Amy Grove*)

Mr. King recused himself from participating in the item due to the City of San Marcos being a client of his. Mr. Richards said since there was no longer a quorum, no action could be taken.

Chairwoman Ritschel designated the four remaining members, Mr. Anderson, Ms. Pearson Schneider, Mr. Wright, and herself, to serve as a panel of the Board to hear public testimony. At a future meeting, with a quorum of the Board, the Order would be brought back for approval.

Mr. Robertus introduced the item and staff member Amy Grove gave the presentation.

Mr. Opper made closing comments.

Ms. Grove and senior staff member, John Odermatt, also made closing comments.

A motion was made by Mr. Wright for the panel to recommend to a quorum of the Board at a future meeting, approval of tentative Addendum 3 to Order No. R9-2006-0044. The motion was seconded by Ms. Pearson Schneider and approved by unanimous vote.

<u>Item 9</u> – Rescission of Waste Discharge Requirements – The Regional Board will consider rescinding Order No. R9-2004-0015, Lake Cuyamaca Recreation and Park District, Lake Cuyamaca Public Recreation Area Southeast of Julian, San Diego County, and allowing commencement of a proposed discharge of sewage waste to groundwater through a subsurface disposal system at the Lake Cuyamaca Public Recreation Area under a waiver of waste discharge requirements. (Tentative Order No. R9-2007-0067) (*Michelle Mata*)

Senior staff member Brian Kelley gave the presentation.

Mr. Kelley responded to concerns raised by Mr. Kimura and made closing comments.

Mr. Robertus said the Waste Discharge Requirements could be rescinded or left in place. He said if rescinded, a waiver could be adopted.

Mr. Richards made comments and suggestions.

Mr. Wright made a motion to approve Order No. R9-2007-0067 and defer regulation of the Lake Cuyamaca public recreation area to the County of San Diego, Department of Environmental Health. Mr. King seconded the motion.

Mr. Anderson asked questions of Mr. Kelley and Mr. Richards.

Mr. Wright amended his motion to require the County of San Diego to conduct water quality monitoring to the satisfaction of the Board.

Mr. Richards said the Board should direct the discharger to do the monitoring, not the County. He said the Regional Board staff could make recommendations to the County on how to exercise their authority.

After discussion, Mr. Wright said his original motion stood with direction to the Executive Officer to require the discharger to conduct a water quality investigation and monitoring program.

Mr. Robertus said if the order was rescinded, he would proceed to regulate the discharge using the waiver policy and require a technical report under a 13267 Investigative Order. He would also investigate the potential consideration for mass loading rather than concentration based compliance.

After further discussion, Mr. Wright's original motion was approved by unanimous vote.

<u>Item 10</u> – Status Report on Provision of Secondary Treatment for Effluent from the International Wastewater Treatment Plant. (Art Coe)

Mr. Robertus introduced the item and indicated that Mr. Art Coe would give the staff presentation.

Mr. Coe reported that the IBWC representatives declined to appear before the Board.
