> MINUTES OF MEETING AUGUST 13, 2008

At 9:00 a.m. Chairman Wright called to order the meeting of the California Regional Water Quality Control Board, San Diego Region at the Regional Water Quality Control Board, 9174 Sky Park Court, San Diego, California.

Item 2 – Public Forum

Gabriel Solmer, San Diego Coastkeeper, said she would like a status update from the Executive Officer on the implementation of the Shelter Island Yacht Basin Dissolved Copper TMDL during Item 4.

Laura Hunter, Environmental Health Coalition, spoke about their concerns with settlement negotiations with William and Heidi Dickerson, and Perry & Papenhausen Construction, Inc., in Coronado. She asked staff to start the "fine clock" and to ask the Attorney General's office to push for a meaningful and quick resolution. Ms. Hunter said the minimum mandatory fine was not enough in this case.

Mr. Rayfield asked for a detailed status report at the September meeting on the issue that Ms. Hunter spoke about. Ms. George said she would find out whether or not it could be discussed in an open session.

Item 3 – Minutes of Board Meetings of June 11 & 25, 2008

Mr. Rayfield moved approval of the June 11 and 25, 2008 minutes. The motion was seconded by Mr. Weber and approved with abstention by Mr. Anderson.

<u>Item 4</u> – Chairman's, Board Members', State Board liaison's and Executive Officer's Reports: These items are for Board discussion only. No public testimony will be allowed, and the Board will take no formal action.

Ms. Pearson Schneider announced that it was her last meeting as a Board Member and thanked her fellow Board Members for all their hard work on the Board and staff for their expertise. Board Members thanked Ms. Schneider for her service on the Board.

Chairman Wright reported that on July 8, 2008 he and Regional Board staff attended a tour of the San Diego County Water Authority's San Vicente pipeline project currently under construction. The tour included a train ride through approximately three miles of completed tunnel.

Chairman Wright also reported that he participated in the Chair's monthly conference call on August 4th and said they discussed how the impact of the state budget impasse was affecting the Regional Boards activities.

Chairman Wright asked for an update on the status of the State Route 241 Foothill South Toll Road Extension in Orange County. Mr. Jimmy Smith gave a brief update on events pertaining to the toll road.

Mr. Robertus briefly reported on the Tijuana River & Estuary Workshop Summary Report - Pollution Control/Cleanup and Wetlands Restoration Strategy item in his report. He also discussed the Budget Report.

Mr. King asked Ms. Hagen about the "Petition of North County Transit District Administrative Civil Liability Order" item in the EO Report. Ms. Hagen gave an update on the petition and said she would keep him posted. Mr. King also asked about the "San Diego MS4 Permit, Test Claim Filed with Commission on State Mandates for Reimbursement" item. Ms. Hagan gave detailed information about the item.

Chairman Wright asked about the "Update on TMDLs" item. Senior staff member David Gibson gave an update.

Mr. Robertus reported on the Shelter Island Yacht Basin Dissolved Copper TMDL as requested by Ms. Solmer in Item 2. Board Members discussed the issue.

Mr. Robertus reported that Board Member Ritschel's term was due to expire on September 30, 2008.

Mr. Robertus also reported on the ongoing problems with the air quality in and around the Regional Board office and said that he made the decision to move toward relocating the office.

Rayfield asked Mr. Robertus what the bill number was for the legislation that would allow local agencies to ban the use of residential water softeners that was signed August 12th. Mr. Robertus said he would provide information on the issue in his September EO Report.

"The discharge of waste shall not cause or contribute to an exceedance of any application water quality objective or standard contained in applicable statewide water quality control plans, the California Toxics Rule, or the San Diego Basin Plan."

Mr. Rayfield made a motion to approve Order No. R9-2008-0049 with errata and the change read into the record. The motion was seconded by Ms. Schneider.

Chairman Wright closed the Public Hearing.

The motion was approved by unanimous vote.

<u>Item 9</u> – NPDES Permit Revision: City of San Diego E. W. Blom Point Loma Metropolitan Wastewater Treatment Plant discharge to the Pacific Ocean through the Point Loma Ocean Outfall: amendment would add a toxicity re-screening requirement upon initiation of chlorination and would also add total residual chlorine monitoring to the Monitoring and Reporting Program (Tentative Addendum No. 2 to NPDES No. CA0107409) (Melissa Valdovinos)

Staff member Melissa Valdovinos gave the presentation.

Other speakers included: Alan Langworthy – City of San Diego Ed Kimura – Sierra Club Chairman Wright closed the hearing. Mr. Robertus recommended approval of the Order.

Ms. Schneider made a motion to approve Addendum No. 2 to Order No. R9-2002-0025. The motion was seconded by Mr. Rayfield and approved by unanimous vote.
