MINUTES OF MEETING MARCH 11, 2009

At 9:00 a.m. Chairman Wright called to order the meeting of the California Regional Water Quality Control Board, San Diego Region at the Regional Water Quality Control Board, 9174 Sky Park Court, San Diego, California.

Item 2 - Public Forum

Verna Rollinger, Laguna Beach City Council, spoke about her concern with the Aliso and Wood Canyons Wilderness Park that was being threatened by the proposed SUPER Project. Ms. Rollinger asked for a status report at the next Regional Board meeting.

Michael Beanan, South Laguna Civic Association, said he was also concerned with the proposed SUPER Project. He then addressed the status of Orange County MS4 Permit and asked that the permit be on the next meeting agenda for adoption.

Cindalee Penny-Hall, Laguna Beach resident, spoke about her concern with the pollutants and toxins that Aliso Creek was picking up on its way to the ocean. She asked for a status report on the proposed SUPER Project at the next Regional Board meeting.

Charlotte Masarik, Village Laguna, spoke about the proposed SUPER Project for Aliso Creek and requested the Board place an item on the next meeting agenda so it could be discussed.

Penny Elia, Sierra Club, said they opposed the proposed SUPER Project and talked about the problems with it.

Senior staff member James Smith gave a brief status report on the Project and the Orange County MS4 Permit.

Board Members asked for a status report at the next Regional Board meeting.
