Mr. Destache asked Mr. Gibson to update the Board on the status of the permit in one year.

Mr. Strawn moved approval of Order No. R9-2011-0022 with modifications based on the new staff recommendation. The motion was seconded by Mr. Green and approved by unanimous vote.
