Enclosed find Amendment No. 3 (Certification Amendment) to Clean Water Act Section 401 Water Quality Certification No. 07C-022 (Certification) issued by the California Regional Water Quality Control Board, San Diego Region (San Diego Water Board) in response to an amendment request submitted by the City of Oceanside for the City of Oceanside Beach Opportunistic Beach Restoration Program Project (Project). The Certification Amendment shows changes in underline/strikeout format to indicate added and removed language. A complete copy of the Certification has also been enclosed for your reference.

Failure to comply with the Certification Amendment may subject the City of Oceanside to enforcement actions by the San Diego Water Board including administrative enforcement orders requiring the City of Oceanside to cease and desist from violations or to clean up waste and abate existing or threatened conditions of pollution or nuisance; administrative civil liability in amounts of up to \$10,000 per day per violation; referral to the State Attorney General for injunctive relief; and/or referral to the District Attorney for criminal prosecution.

Documents over 50 megabytes will not be accepted via e-mail and must be placed on a disc and delivered to the San Diego Water Board, 2375 Northside Drive, San Diego, CA 92108. Each electronic document must be submitted as a single file, in Portable Document Format (PDF) format, and converted to text searchable format using Optical Character Recognition (OCR). 

On May 20, 2010, Clean Water Act Section 401 Water Quality Certification No. 07C-022 (Certification) was issued to the City of Oceanside (Applicant) for the Beach Opportunistic Beach Restoration Program Project (Project). On July 13, 2010, an Amended Certification was issued to correct typographical errors in the original Certification. On April 16, 2015, a second Amended Certification was issued to extend the original Certification expiration date.

By letter dated July 13, 2015, Moffatt & Nichol, on behalf of the Applicant, requested the Amended Certification be amended to add a second beach nourishment placement site to the Certification.

Based on the Applicant's request, the California Regional Water Quality Control Board, San Diego Region (San Diego Water Board) is amending the Amended Certification to add the new placement site between Seagaze Drive and Pine Street referred to as the "Northern Placement Site". Except as modified or superseded by the Amended Certification modifications set forth below, all of the findings, provisions and other requirements of Amended Certification No. 07C-022 remain in full force and effect. The following changes are made to Amended Certification No. 07C-022 and are shown in underline/strikeout format to indicate added and removed language:

1. Page 2, Project Description is modified as follows:

Sand nourishment placement sites are located between Seagaze Drive and Pine Street (Northern Placement Site) and Oceanside Boulevard and the mouth of Loma Alta Creek mouth (Southern Placement Site), Oceanside, CA. City of Oceanside Beach Opportunistic Beach Restoration Program Certification No. 07C-022, Amendment 3 May 20, 2010 Amended on July 13, 2010 Amended on April 16, 2015 Amended on July 18, 2016
