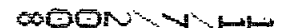
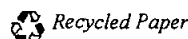
The California Regional Water Quality Control Board, San Diego Region (Regional Board) has reviewed the following monitoring reports submitted by the Kkottongnae Inc. in accordance with Monitoring and Reporting Program Order No. 93-43.

The following violations of the Effluent Monitoring Requirement B.1 of Monitoring and Reporting Program No. 93-43 were identified in these monitoring reports:

1. Daily flow rates of effluent were not recorded for any period in the above reports. The flow rates are to be measured daily and reported semiannually.
2. The effluent samples analyzed for biochemical oxygen demand exceeded the daily maximum Discharge Limit of 50 mg/L in the June 2007, December 2007, and June 2008 samples. The effluent samples analyzed for total suspended

solids exceeded the daily maximum Discharge Limit of 50 mg/L in June 2007. The Monitoring and Reporting Program for Order No. 93-43 states:

"The discharger shall increase the sampling frequency from quarterly to monthly whenever the monitoring data indicates a violation of the daily maximum limit for either biochemical oxygen demand, total suspended solids, or pH limit as specified by Discharge Specification B.1 of this Order. The monthly monitoring shall continue until the discharger achieves compliance with these limitations for two consecutive months. After compliance is achieved, the discharger shall resume sampling at the quarterly frequency."

The sampling frequency was not increased to monthly after any of the noted exceedances.

3. The effluent samples were not analyzed for nitrate, total dissolved solids, chloride, methylene blue active substance, boron, or iron. This is required on a semiannual basis.
4. Most of the analysis for pH exceeded the 15 minutes holding time specified by the testing laboratory. All analysis must adhere to laboratory specifications.

The following violation of the Monitoring Requirement C prescribed in the Monitoring and Reporting Program of Order No. 93-43 was identified in these monitoring reports:

Groundwater Monitoring is to be performed annually and analyzed for total dissolved solids and nitrate. This was not done.

The following violation of the Monitoring Requirement D prescribed in the Monitoring and Reporting Program of Order No. 93-43 was identified in these monitoring reports:

Potable Water Supply monitoring is to be performed annually and analyzed for total dissolved solids and nitrate. This was not done.

The Regional Board urges Kkottongnae Inc. to take adequate measures to prevent further violations of Effluent Monitoring Requirement B.1. The cited violations are not a priority for further enforcement action unless similar violations in the future demonstrate that Kkottongnae Inc. is having chronic problems complying with Order No. 93-43.

The next monitoring report due is the 2008 Annual Report, due January 30, 2009.


