**SUBJECT: REVIEW OF THE 2008 AND 2009 ANNUAL MONITORING REPORT
FOR INDIAN OAKS TRAILER RANCH**

The California Regional Water Quality Control Board, San Diego Region has reviewed the January-December 2008 and January-December 2009 annual monitoring reports submitted by Indian Oaks Trailer Ranch (Indian Oaks) in accordance with the Monitoring and Reporting Program of Order No. 88-24.

The following violations of Section D. 4 (Reporting Requirements) of Order No. 88-24 were identified in the reports submitted:

1. Supply water analyses results for total dissolved solids, chloride, sulfate, and nitrate were not included in the 2009 annual report. Section B (Supply Water Monitoring) of Monitoring and Reporting Program No. 88-24 requires Indian Oaks to analyze a supply water sample for total dissolved solids, chloride, sulfate, and nitrate annually.
2. Information regarding monthly water consumption and monthly visitor use days were not included in the 2008 and 2009 annual reports. Section B (Supply Water Monitoring) of Monitoring and Reporting Program No. 88-24 requires Indian Oaks to report the monthly water consumption and monthly visitor-use days annually.
3. Information regarding disposal of solids removed from the facility septic tanks was not included in the 2008 and 2009 annual reports. Section C (Waste Disposal Log) of Monitoring and Reporting Program No. 88-24 requires Indian Oaks to submit a log of the type, quantity, and manner of disposal of waste generated annually.

Please be aware these violations subject Indian Oaks to possible further enforcement action by the San Diego Water Board, including administrative enforcement orders requiring the you to cease and desist from violations, or to clean up waste and abate

existing or threatened conditions of pollution or nuisance; administrative assessment of civil liability in amounts of up to \$5,000 per day per violation;¹ and referral to the State Attorney General for injunctive relief. Consequently, the San Diego Water Board strongly urges your compliance with Section B and C in preparation of the January-December 2010 annual monitoring report due by January 30, 2011.
