# Missing Reports:

- Quarterly and annual SMRs specified in this Order are to be submitted as required by Attachment E, Monitoring and Reporting Program (MRP). The following reports were not received:
  - i. January-March 2008 quarterly;
  - ii. October-December 2008 quarterly;
  - iii. April-June 2009 quarterly;
  - iv. October-December 2009 quarterly;
  - v. October-December 2011 quarterly;
  - vi. April-June 2012 quarterly;
  - vii. July-September 2012 quarterly;
  - viii. July 2008-July 2009 annual.

### Late Quarterly Reports: Attachment E – MRP – Section X.B.2

2. Quarterly SMRs are due for the first quarter (January–March) on May 1, second quarter (April–June) on August 1, third quarter (July–September) on November 1, and the fourth quarter (October–December) on February 1. The following quarterly reports were not submitted by the due date:

- ii. January March 2009, received May 5, 2009;
- iii. April June 2010, received August 4, 2010;
- iv. January-March 2012, received June 26, 2012.

Pursuant to the California Water Code (CWC), the violations noted could be subject to additional enforcement action(s) by the San Diego Water Board including a time schedule order, cease and desist order, cleanup and abatement order, imposition of administrative civil liability, referral to the district attorney for criminal prosecution, or referral to the attorney general. Administrative civil liability amounts that may be imposed by the San Diego Water Board under authority of CWC Section 13385 include up to \$10,000 per day per violation.
