The California Regional Water Quality Control Board, San Diego Region (San Diego Water Board) has reviewed the monitoring reports Listed in Table 1 below. The Rancho Santa Fe Community Service (Discharger) submitted the monitoring reports as required by the Monitoring and Reporting Program No. 92-04.

The following violations of Discharge Specifications in Order No. 92-04 Section B. 1 were identified in the monitoring reports and are listed below:

1. The discharge specification for the monthly average concentration of manganese is established at 0.15 milligrams per liter (mg/L) and was exceeded on the following dates:

Table 2. Exceedances of Monthly Average Manganese Discharge Specification

July 11, 2017	0.25
January 2, 2017	0.23
April 3, 2018	0.28

- The discharge specification for the daily maximum concentration for manganese is established at 0.20 mg/L and was exceeded on the following dates:



- The discharge specification for the daily maximum concentration of chloride, established at 500 mg/L, was exceeded on April 3, 2018 at a reported concentration of 540 mg/L
- The discharge specification for the daily maximum concentration of Total Dissolved Solids (TDS), established at 1,500 mg/L, was exceeded on January 3, 2017 at a reported concentration of 1,556 mg/L.

According to Addendum 1 of Order No. 92-04, the discharger is required to submit monthly monitoring reports. Please begin reporting monthly starting with the month of October 2018. The next monitoring report due is the June-August quarterly report which is due by **October 30, 2018**.
