ORDER NO. 79-112

REISSUING NPDES PERMITS FOR THE DISCHARGERS
CITED HEREIN

The California Regional Water Quality Control Board, San Francisco Bay Region (hereinafter called the Board), finds that:

1. The parties listed below, hereinafter called the dischargers, have previously been issued permits by this Board under the National Pollutant Discharge Elimination System (NPDES) in the Orders indicated:

2. Said dischargers have submitted applications for reissuances of their NPDES permits.
3. The waste discharges remain as described in the Orders cited above.
4. The Board is not required to comply with the provisions of Chapter 3 (commencing with Section 21100) of Division 13 of the Public Resources Code (California Environmental Quality Act) as this is an NPDES permit and is exempt from such provisions per Section 13389 of the Water Code.
5. The Board has notified the dischargers and interested agencies and persons of its intent to prescribe waste discharge requirements for the proposed discharge and has provided them with an opportunity for a public hearing and an opportunity to submit their written views and recommendations.
6. The Board, in a public meeting, heard and considered all comments pertaining to the discharges.

7. This Order shall serve to reissue National Pollutant Discharge Elimination System permits pursuant to Section 402 of the Federal Water Pollution Control Act, or amendments thereto, and shall take effect at the end of ten days from the date of hearing provided the Regional Administrator has no objections.

IT IS HEREBY ORDERED, pursuant to the provisions contained in Division 7 of the California Water Code and Federal Clean Water Act and regulations and guidelines adopted thereunder that:

1. The NPDES permits as contained in the Orders cited in Finding 1 of this Order are hereby reissued.
2. The expiration dates contained in said Orders shall henceforth read: May 1, 1981.
3. All terms and conditions contained in said Orders shall remain in full force and effect without modification.
