## OF COMMENT PERIOD ON THE DRAFT FINAL REMEDIAL ACTION PLAN FOR PROPOSED DEVELOPMENT OF THE PETALUMA QUARRY PROPERTY 1600 PETALUMA BOULEVARD SOUTH

The Water Board welcomes your participation in the review and comment on the "*The Draft Final Remedial Action Plan (Draft Final RAP)* for the proposed development of the Petaluma Quarry Property at 1600 Petaluma Boulevard South. Attached is a fact sheet containing a brief summary of the subject site, the proposed development project at the site, environmental investigations completed to date, and the proposed remedial actions and/or mitigation measures to protect human health. A *Draft Final Risk Management Plan* (RMP) has also been prepared to manage soil and groundwater with chemicals at concentrations above action levels in the unlikely event they are potentially encountered during construction and post development activities. The *Draft Final RAP*, which contains a more thorough discussion of the information presented in the fact sheet, and the *Draft Final RMP* are available for review at the following locations:
