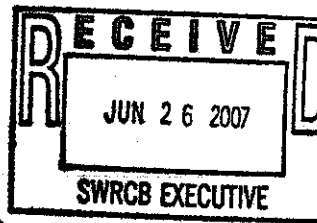

Comment Letter:  
Suction Dredge Mining.

ATTENTION: Assembly Bill 103a  
(AB 103a)

According to the United States of America's Constitution, Bill of Rights Citizens of the USA are Free. Slavery has been Abolished.

Your attempts to implement Assembly Bill 103a (AB 103a) is NOT warranted as a State/Government Global Emergency or Threat to Endangered Aquatic Species, but another attempt to undermine, take control, to corner, to regulate, to dominate, to defraud, to redeem, to enslave the already enslaved, and or otherwise, militarialize all known/unknown Gold Ore, Placer, bullion natural resources in the United States.

These are but 1% of the Gold Producing Area's that Towns, Cities, Counties of State/Government who Fly the Blue Arms Flag in Courtrooms (Military Government's Subordinates) take possession of, ether by Force or Underbought away from honest hard working "Miners". When does the Enslavement End?

I like the way "Newsweek Magazine" March 11th 1933 puts it; "March 6-9 1933 Franklin Roosevelt closed all the U.S. Banks, and instituted a proclamation that declared: "An embargo on the withdrawal of all Gold and Silver...etc." Then in 1965 the President Johnson, after President Kennedy was assassinated by his own agents, signed the "Coinage Act of 1965", altering the Coinage Act of 1792 for the first time, changing the definition of what constitutes a "dollar". In 1977, pursuant to "Fidelity Bank Guarantee vs. Henwood 307 U.S. 847 (1939); holds that 31 USC 5118 was enacted to remedy the specific evil of tying debt to any particular Currency or requiring payment in a greater number of dollars than promised. Since October of 1977, there can be no requirement of repayment in legal tender either, since legal tender was not loaned, and repayment

need only be made in equivalent Kind: A negotiable instrument representing credit.

What does all this mean?

In Conclusion gentlemen what this means is, "we the Free People" (Land of the Free) don't believe you, don't trust you. Your Authority as Fish, and Game Specialist are "questionable". Inactments you imposed in the beginning should of been acceptable until death. That's why you make the big bucks is it not? - 1) Take our "three stage sluice dredge for example". It is designed to capture gold because gold is dense, and collects in the specially designed riffle system which recovers 90% of all visible gold.
- 2) When you thought 90% of all visible gold recovered was impressive with Stage #1, Stages #2 and #3 collect more coarse, and fine gold, and black sand, and also other dense elements.
- 3) The elements of black sand are made up of two crystalline oxides of iron: magnetite and hematite. Hematite has a density of 5.3, and magnetite has a density of 5.2. This means, those black particles are 5.0 times heavier than water.
- 4) Gold has a density of 19.30  
Gold's Atomic Weight is 196.96  
(Compare the following elements vs. Gold)

Mercury is a poisonous metallic element.

Lead is also a poisonous metallic element.


