State Water Resources Control Board (State Water Board) for entry of an order enforcing the Consent Judgment entered on January 21, 2010 (Consent Judgment) and assessing in its entirety the suspended penalty of \$2,500,000.00 came on for hearing on January 23, 2015, in Department 44, Judge Mark Borenstein presiding. The motion hearing was held and continued from January 23 to February 10, 2015, and held and continued again from February 10 to February 17, 2015.

The Court, having considered the papers and evidence submitted by the parties and the arguments of the parties at the hearing, and finding that defendant City of Long Beach (City) engaged in Suspended Penalty Conduct as defined in the Consent Judgment, adjudges and orders as follows:
