## RE: COMMENT LETTER - JUNE 20, 2017 BOARD MEETING - FFY 2017 CWSRF IUP

Dear Chair Marcus and Executive Director Howard:

We appreciate the opportunity to comment on the above-referenced Draft CWSRF IUP. We fully understand the difficulty in managing programs when expressed needs are much greater than the available resources. However, there can be at least one major improvement to the Draft CWSRF IUP. Specifically, better adherence to the State Board's Strategic Goal 6 – Enhancing consistency across Water Boards.

The Palmdale Water District (PWD) is a participant in two water recycling projects submitted for funding under the Proposition 1 Water Recycling Program. Both projects have completed applications and reviews are pending. PWD is the sole sponsor of the Palmdale Regional Groundwater Recharge and Recovery Project and is a partner in the Palmdale Recycled Water Authority (PRWA), a JPA along with the City of Palmdale, which is sponsoring the Recycled Water Line Phase 2 Project. The two projects are listed below.

The District is concerned that water entities located in Region 6 (Lahontan Regional Water Quality Control Board) appear to be at risk in the future of not receiving grant funding for the water recycling projects. We have reviewed the Draft April 20, 2017 Intended Use Plan and provide a summary table to highlight this concern.
