# REVISED NOTICE OF PUBLIC STAFF WORKSHOPS, PUBLIC BOARD WORKSHOP

AND PROPOSED FIRST REVISED TOXICITY PROVISIONS AND WATER QUALITY CONTROL PLAN FOR INLAND SURFACE WATERS, ENCLOSED BAYS, AND ESTUARIES OF CALIFORNIA

**NOTICE IS HEREBY GIVEN** that, on or before July 25, 2019, the State Water Resources Control Board (State Water Board) will make available the First Revised Draft Toxicity Provisions, which is part of the First Revised Draft Water Quality Control Plan for Inland Surface Waters, Enclosed Bays, and Estuaries of California at the <a href="Statewide Toxicity Provisions web site">Statewide Toxicity Provisions web site</a>.

The revisions were made in response to comments received during the public comment period. The State Water Board is not accepting written comments on the First Revised Draft Toxicity Provisions at this time.

#### **BACKGROUND**

The State Water Board is developing the Toxicity Provisions to establish numeric water quality objectives for both acute and chronic toxicity, and a program of implementation to protect aquatic life beneficial uses. As part of this project, staff is proposing the establishment of the Water Quality Control Plan for Inland Surface Waters, Enclosed Bays, and Estuaries of California (ISWEBE Plan), which will be a single planning document that includes all the water quality control plan provisions adopted by the State Water Board for surface waters excluding open bays and the ocean.

#### **PURPOSE OF THE WORKSHOPS & PROCEDURAL MATTERS**

The purpose of the first and second public staff workshops on August 13 and August 16, 2019 is to provide information about the First Revised Draft Toxicity Provisions to the public. State Water Board staff will be available to answer questions.

The purpose of the **second third public staff workshop on August 28, 2019**, is to provide an opportunity for an open discussion between members of the public and State Water Board staff regarding the First Revised Draft Toxicity Provisions.

The purpose of the **public board workshop on October 3, 2019**, is to provide an opportunity for an open discussion between the State Water Board, staff, and members of the public regarding the First Revised Draft Toxicity Provisions. To ensure a productive and efficient workshop in which all participants have an opportunity to participate, oral presentations may be time-limited.

A quorum of the State Water Board members may be present at the <u>August 13 and August 28</u> public staff workshops and the public board workshop; however, no board action will be taken. Although no formal decisions will be made, the board may provide direction to staff. The State Water Board will schedule a subsequent meeting at which it will consider adopting the proposed Toxicity Provisions and ISWEBE Plan.

## POSSIBLE ADDITIONAL REVISIONS - OPTIONS UNDER CONSIDERATION

Several issues raised by commenters are not reflected as changes in the First Revised Draft Toxicity Provisions. The State Water Board may consider options to remove or revise the reasonable potential analysis section of the implementation provisions and require all non-storm water NPDES¹ dischargers to conduct routine chronic toxicity monitoring and be subject to effluent limitations, unless the permitting authority grants an exemption. The State Water Board may also consider options to defer the use of *Ceriodaphnia dubia* for chronic toxicity testing to assess compliance with effluent limitations until a date certain and to conduct a study to identify ways to reduce variability when conducting chronic *C. dubia* toxicity tests. Please be prepared to discuss these options at the workshops.
