NOTICE OF PETITION FOR CHANGE FOR PERMIT 19400 (APPLICATION 25727)

COUNTY: Sacramento County STREAM SYSTEM: Sacramento River

Natomas Central Mutual Water Company (NCMWC), c/o Dee Swearingen, General Manager, 2601 West Elkhorn Boulevard, Rio Linda, CA 95673 has filed a petition to change the place of use and purpose of use under water right Permit 19400 (Application 25727). NCMWC proposes to provide up to 644 acre-feet annually (afa) of water under Permit 19400 to Sacramento Regional County Sanitation District's Lower Northwest Interceptor (LNWI), a sanitary sewer pipeline that delivers wastewater from West Sacramento and the Natomas area to the Sacramento Regional Wastewater Treatment Plant in Elk Grove. The proposed change would add the LNWI located within the SE½ of SW½ & SW½ of SE½ of Section 14, T9N, R4E, MDB&M, to the authorized place of use under Permit 19400. Industrial use would also be added as an authorized purpose of use in the expanded place of use.
