Point of Diversion or Rediversion

License 1050 authorizes direct diversion from four permanent points on the Sacramento River and two permanent points on the Natomas Cross Canal. A map showing the following authorized points of diversion is attached.

Present:

License 1050 authorizes irrigation use within the entire Natomas Central Mutual Water Company's (NCMWC) service area, and municipal and industrial use within Sacramento Metropolitan Airport and its Special Planning Area only.

As granted in the Order Allowing Change in Place of Use dated June 27, 1979 filed with the SWRCB, and described as follows:

5,903.54 net acres within a gross area of 51,091 acres as shown on the map filed with the State Water Resources Control Board within the following Sections:

Proposed:

The Lower Northwest Interceptor (LNWI) is an approximately 20 mile long, 5 to 10 foot diameter, sanitary sewer pipeline which extends from Natomas south through West Sacramento and then trends east across the Sacramento River, terminating at the Sacramento Regional Wastewater Treatment Plant (SRWTP) located in Elk Grove.

The place of use is the same as authorized in WR Order 2007-0023-DWR. The LNWI pipeline would be added to the place of use under License 1050. A map showing the location of the LNWI is available for viewing on the Division's website at www.waterrights.ca.gov/application/tempurgnotices.htm.

Petitioner proposes to add portions of the SE¼ of SW¼ & SW¼ of SE¼ Section 14, T9N R4E, (APN's 225-0180-012 & 225-0180-055) to its

existing place of use authorized for M&I purposes (See figure I). The place of use to be added is the location of the LNWI pipeline at the New Natomas Pump Station (NNPS). The Petitioner proposes to use the NNPS for the LNWI located within SE¼ of SW¼ & SW¼ of SE¼ Section 14, T9N R4E. The Intake for LNWI is located within the channel of the East Drainage Canal of Reclamation District 1000 (RD1000). Installation of the Intake and construction of the pump station was approved by California Department of Fish & Game, Army Corps of Engineers, and US Fish and Wildlife Service. These approvals are attached to this document. SRCSD will be the user of water subject to the change.

Purpose of Use

Present:

License 1050 authorizes NCMWC to direct 42.18 cfs from April 1 through October 1 of each year for irrigation use within the entire NCMWC's service area, and municipal and industrial use within Sacramento Metropolitan Airport and its Special Planning Area only.

Pursuant to SWRCB Order dated July 12, 1990 authorizing municipal, industrial and domestic uses in the area shown on a map accompanying the Order filed with the SWRCB revised March 9, 1990, and described as:

Lands located within the Sacramento Metropolitan Airport and the Sacramento Airport Special Planning Area located within T10N, R3E Sections 24, 25 & 36 and T10N, R4E Sections 19, 20, 29, 30, 31 & 32.

Proposed:

NCMWC proposes to deliver water to the SRCSD for industrial use (testing and flushing) within the LNWI. Water would flow via gravity from RD1000's East Drainage Canal into the LNWI pipeline and used for testing and flushing throughout the length of the pipeline. The regular operational flushing schedule could use up to 6 MG per flush or about 18.4 af every Tuesday during the requested period. However, SRCSD could potentially flush the entire system which would require a flush of up to 15 MG or 46 af every other Tuesday from April 1 to October 1. Once used to test or flush the LNWI, the transfer water would be treated at the SRWTP and discharged to the Sacramento River as a small portion of the SRWTP's effluent.

The proposed use serves to preserve the resources of the Sacramento River by essentially being a non-consumptive use. Also, the water discharged to the river would be subject to the same water quality requirements of the Regional Water Quality Control Board (RWQCB) as all effluent from the SRWTP. The resulting releases would also increase the amount of water in the river, though it would be such a small portion of the average river flow the change would be undetectable to downstream users.

• Reason for Proposed Change:

Normal operations for the LNWI require testing and flushing flows delivered at the intake. Water would be gravity fed at the intake from RD1000's East Drainage Canal into the LNWI and used for testing and flushing throughout the length of the pipeline.

Dear Mr. Herrera:

Transmitted herewith please find a Petition for Change by Natomas Central Mutual Water Company (NCMWC). The proposed change is for 644 acre-feet of water to be diverted pursuant to License 1050, to be used by Sacramento County Regional Sanitation District for testing and flushing of the Lower Northwest Interceptor (LNWI) project. The petition seeks to add Municipal & Industrial use at the New Natomas Pump Station Intake to the existing purpose of use and the LNWI pipeline to the existing place of use.

NCMWC diverts water from the Sacramento River at various points of diversion and serves water for agricultural and other purposes under contract with the United States Bureau of Reclamation (USBR) and pursuant to various Permits and Licenses. Water that is diverted is conveyed through a closed system of canals and ditches and normally does not return to the river. In this regard 100% of the diversions are in effect consumptively used.

Water accrues to the NCMWC ditch and canal system from various sources including return flow from irrigation, both from groundwater wells and water diverted from the Sacramento River for irrigation, urban runoff, storm runoff and from groundwater discharged by a neighboring sturgeon farm. The sturgeon farm pumps about 2700 gpm (3.88 MGD) of water from groundwater wells that is discharged to the NCMWC system after circulating through the sturgeon farm.

A Petition for Temporary Transfer of Water/Water Rights was submitted in March 2006 and approved in September 2006 for the transfer of 1,679 acre-feet pursuant to Permit 19400 as stated in WR Order 2006-0014-DWR. Another Petition for Temporary Transfer of Water/Water Rights was submitted in April of 2006 and approved in June 2006 for the transfer of 406 acre-feet pursuant to License 1050 as stated in WR Order 2007-0023-DWR. LNWI has received approvals for the facilities that will be used as part of the proposed transfer from the Department of Fish Game (DFG), U.S. Fish and Wildlife Service, Regional Water Quality Control Board (RWQCB) and others.
