NOTICE OF PETITION FOR CHANGE FOR PERMIT 10478 (APPLICATION 13156)

COUNTIES: San Joaquin, Amador STREAM SYSTEM: Mokelumne River

East Bay Municipal Utility District (EBMUD) filed a petition for change to add a clarifying term to Permit 10478. The proposed term makes a technical clarification to conform to the principles and procedures that the State Water Resources Control Board (State Water Board) currently uses to analyze diversions. The petitioned change will not result in any modifications to current operations of the Mokelumne Project. The requested change is incorporated in the attached draft amended permit. EBMUD updated its permit maps in 2010 to accurately depict the parcels that it presently serves under approvals issued by the Local Agency Formation Commission. The updated maps are incorporated in the draft amended permit.
