This petition seeks to add San Luis Reservoir (SLR) as an authorized point of rediversion (PORD) for Permit 15026 for the purpose of allowing carryover storage of up to 70,000 acre-feet per year (af/yr) of water in SLR for Central Valley Project (CVP) contractors until December 31, 2025. No facilities will be constructed, and no diversions from natural watercourses will occur, in conjunction with the proposed change.

The water that will be stored in SLR as a result of the addition of the proposed PORD is Yuba County Water Agency (YCWA) transfer water, the transfer of which Corrected Order WR 2008-0014 authorized within the CVP and SWP service areas until December 31, 2025.

YCWA is preparing an addendum to its Yuba Accord EIR for the proposed change of adding SLR as an authorized PORD and for the carryover storage of up to 70,000 af/yr in SLR for CVP contractors through 2025. YCWA anticipates presenting that addendum to the YCWA Board of Directors for its consideration and possible certification in October 2014.
