## **NOTICE OF WASTEWATER CHANGE PETITION WW0090**

COUNTY: San Luis Obispo STREAM SYSTEM: Salinas River

The City of El Paso de Robles (City) has filed a wastewater change petition with the State Water Resources Control Board pursuant to Water Code section 1211. The petition seeks authorization to reduce the discharge of treated wastewater from the City's wastewater treatment plant to the Salinas River from April through October of each year. This proposed change would reduce flow in the Salinas River, and will be reviewed by the State Water Resources Control Board pursuant to the provisions of Chapter 10 of Part 2 of Division 2 of the Water Code.
