The City of Petaluma (City) has filed a wastewater change petition with the State Water Resources Control Board pursuant to Water Code section 1211. The City requests authorization to reduce the rate and volume of treated wastewater discharged from the Ellis Creek Water Recycling Facility to the Petaluma River from October 21 of each year to April 30 of the succeeding year.
