The Sanitation Districts of Los Angeles County (Petitioner) has filed a wastewater change petition with the State Water Resources Control Board pursuant to Water Code section 1211. The Petitioner requests authorization to reduce the rate and volume of treated wastewater discharged from the Whittier Narrows Water Reclamation Plant to the Rio Hondo Channel and/or San Gabriel River during all months of the year.
