## NOTICE OF PETITION FOR CHANGE FOR WATER RIGHT LICENSE 5063A (APPLICATION 8801A) OF HOWELL MOUNTAIN MUTUAL WATER COMPANY

On July 6, 2017 the Howell Mountain Mutual Water Company (HMMWC) filed a petition to change water right License 5063A with the State Water Resources Control Board, Division of Water Rights pursuant to Water Code section 1701. HMMWC wishes to add an existing diversion (Point 8) as an additional point of diversion, add existing Point 1 (Deer Lake) as a point of re-diversion, and change the distribution of storage by adding Cooksley Lake as a place of storage.
