NOTICE OF PETITION FOR EXTENSION OF TIME FOR PERMIT 19895 (APPLICATION 28473)

COUNTY: San Bernardino STREAM SYSTEM: Day Creek and East Etiwanda Creek,

tributary to the Santa Ana River

On May 5, 2004, Chino Basin Watermaster originally filed a petition for extension of time for water right Permit 19895 (Application 28473) with the State Water Resources Control Board, Division of Water Rights (Division). With the petition, as modified in September 2012, Chino Basin Watermaster requests an extension of time for water right Permit 19895 to December 31, 2057.

Points of Diversion:	(1) To Spreading Area "A" (Water Percolation Basins) Located within SE¼ of NE¼ of Section 18, T1N, R6W, SBB&M (2) To Spreading Area "B" (Day Creek Basin) Located within NE¼ of NE¼ of Section 31, T1N, R6W, SBB&M (5) To Spreading Area "C" (Wineville Basin) Located within NW¼ of SE¼ of Section 29, T1S, R6W, SBB&M
Points of Diversion and Rediversion:	(3) To Spreading Area "C" (Wineville Basin) Located within SE¼ of NE¼ of Section 31, T1S, R6W, SBB&M (4) To Spreading Area "D" (Riverside Basin) Located within NE¼ of SE¼ of Section 6, T2S, R6W, SBB&M
Amount:	Diversion of a maximum of 15,000 acre-feet per annum to be collected to underground storage at a combined maximum rate of 179 cubic feet per second (cfs) as follows: Spreading Area "A" – 63 cfs Spreading Area "B" – 59 cfs Spreading Area "C" – 29 cfs Spreading Area "D" – 28 cfs
Season:	November 1 of each year to April 30 of the succeeding year
Purposes of	Irrigation, Municipal, and Industrial
Place of Use:	The service area of the Day Creek Water Project within T3S to T1N and R5W to R9W, inclusive SBB&M.
