RE-NOTICE OF WATER RIGHT APPLICATION A032958 AND ASSOCIATED PETITION TO DEDICATE WATER REPORTED UNDER STATEMENT OF DIVERSION AND USE S001220 FOR FISH AND WILDLIFE PRESERVATION AND ENHANCEMENT (ADJUDICATED WATER RIGHT J000028)

COUNTY: SAN MATEO

STREAM SYSTEM: SAN GREGORIO CREEK

The subject application and petition are being re-noticed because the applicant/petitioner failed to post the original notice within 20 days of issuance, as required by Water Code section 1322. The time period allowed for filing written protests against approval of the subject application and petition has been extended accordingly. The application, petition, and notice are unchanged.

On August 06, 2018, Peninsula Open Space Trust filed Water Right Application A032958 and an associated petition pursuant to Water Code section 1707 with the State Water Resources Control Board, Division of Water Rights. The subject petition proposes to dedicate adjudicated water reported under Statement of Diversion and Use S001220 for Fish and Wildlife Preservation and Enhancement in San Gregorio Creek (Adjudicated Water Right J000028). The point of diversion in the subject petition and statement of diversion and use is referenced as Diversion No. 225 in Decree No. 355792 issued by the San Mateo County Superior Court in January 1993.
