NOTICE OF WASTEWATER CHANGE PETITION WW0100

COUNTY: Los Angeles

STREAM SYSTEM: San Gabriel River

The County Sanitation Districts of Los Angeles County (Petitioner) has filed a wastewater change petition with the State Water Resources Control Board pursuant to Water Code section 1211. The Petitioner requests authorization to reduce the discharge of treated wastewater from the San Jose Creek Water Reclamation Plant by up to 0.05 million gallons per day to the San Jose Creek and/or San Gabriel River during all months of the year.
