NOTICE OF PETITION FOR TEMPORARY URGENCY CHANGE FOR PERMIT 13776 (APPLICATION 18115)

COUNTIES: TEHAMA, GLENN STREAM SYSTEM: STONY CREEK

The United States Bureau of Reclamation (Permittee) has filed a petition for temporary urgency change to extend the season of rediversion of Permit 13776 (Application 18115). Under Permit 13776, water is diverted to storage in Black Butte Reservoir and rediverted at the Stony Creek Siphon into the Tehama-Colusa Canal. With the temporary urgency change petition, the Permittee has proposed to increase the permitted season of rediversion for 30 days, from May 15, 2012 to June 15, 2012. The season of diversion will not be extended since the water to be rediverted is currently stored in Black Butte Reservoir.

Point of Rediversion:	At the Stony Creek Siphon to the Tehama-Colusa Canal within SW¼ of NW¼ of Section 13, T22N, R3W, MDB&M
Amount:	160,000 acre-feet by storage and 38,293 acre-feet by release from storage for rediversion
Season of Diversion:	November 1 to April 30 of the succeeding year
Season of Rediversion	Present: April 1 to May 15 and September 15 to October 29 Proposed: April 1 to June 15 and September 15 to October 29
Purpose of Use:	Domestic, Irrigation, Municipal, Industrial, Recreational, Fish and Wildlife Protection and Enhancement
Place of Use:	Within the service area of the districts, municipalities, water companies, corporations, and other legal entities within the gross place of potential use delineated on maps for the Central Valley Project on file with the Division
