## NOTICE OF PETITION TEMPORARY URGENCY CHANGE FOR PERMIT 21185 (APPLICATION A028609) OF JUNE LAKE PUBLIC UTILITY DISTRICT

COUNTY: Mono

STREAM SYSTEM: Fern Creek

On May 20, 2014, the June Lake Public Utility District (Petitioner) filed a temporary urgency change petition with the State Water Resources Control Board, Division of Water Rights requesting approval of a temporary change to water right Permit 21185 (Application A028609) pursuant to Chapter 6.6 of Part 2 of Division 2 of the Water Code. The petition proposes to temporarily reduce the minimum bypass flow requirement of Permit 21185 from 200 gallons per minute to 25 gallons per minute. Additional water supply made available by the proposed change will be used to help meet projected potable water demand in the Petitioner's Down-Canyon Service Area during the 2014 water year drought.
