NOTICE OF PETITION TEMPORARY URGENCY CHANGE FOR LICENSE 13830 (APPLICATION 22377) OF The Sea Ranch Water Company

COUNTY: Sonoma

STREAM SYSTEM: South Fork Gualala River

On February 28, 2018, The Sea Ranch Water Company (Petitioner) filed a temporary urgency change petition with the State Water Resources Control Board, Division of Water Rights (State Water Board) requesting approval of a temporary change to water right License 13830 (Application 22377) pursuant to Chapter 6.6 of Part 2 of Division 2 of the Water Code. The petition seeks authorization to temporarily forego bypass requirements to continue to provide potable water to the residents of The Sea Ranch while required repairs are conducted at the storage reservoir.

Summary of License 13830:

Source:	South Fork Gualala River Underflow tributary to Pacific Ocean
Points of Diversion:	SW1/4 of SE1/4 of Section 16, T10N, R14W, MDB&M
Season of Diversion:	January 1 to December 31
Amount:	0.72 cubic foot per second by direct diversion, with 310 acre-feet per annum limit.
Bypass:	Existing: 5 cfs June 1 to November 30; 25 cfs December 1 to March 31; 10 cfs April 1 to May 31. Proposed: 0 cfs April 1 to September 30 of 2018.
Purpose of Use:	Municipal
Place of Use:	Within Sea Ranch Water Company service area, as shown on map on file with the Division of Water Rights.

Pursuant to Water Code section 1438, subdivision (a), the State Water Board may issue an order approving or denying a temporary urgency change petition in advance of public notice.

Pursuant to California Water Code section 1438, subdivision (d), any interested person may file an objection to the temporary change. Objections must be received by the Division by **4:30 p.m. on April 23, 2018**. Objections filed with the Division must indicate the manner in which service upon the Petitioner of a duplicate copy of the protest has been made.
