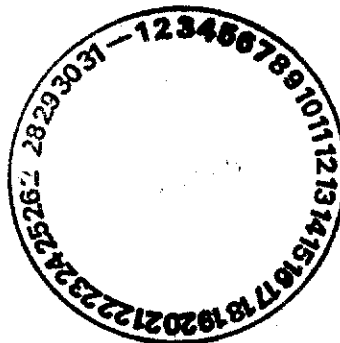

The Department of Water Resources (DWR) and the Bureau of Reclamation (Reclamation) submit the enclosed comments for the State Water Resources Control Board (SWRCB) Workshop on revisions to the Bay-Delta Water Quality Control Plan with respect to municipal and industrial beneficial use objectives and the location of the compliance monitoring station at Pumping Plant Number 1 (Topic 4 of the Workshops).
